11. To Receive Reports:

Ward councillor RM confirmed the ward councillor grant is available and open for applications.

RM discusses the possibility of traffic/surveying cameras in the village to monitor areas where drivers are not obeying road rules or where dangerous driving occurs. Councillors and residents to suggest potential sites.

The Ward Councillors are monitoring closely the Universal Studio application and will provide an update when they know more.

Chair MS gives an update on All Saints Church. The service attendance continues to grow, there were over 40 people at the easter service. The Church needs new heating and maintenance work completing and the PCC are exploring ideas to raise funds. There will be a village fete in September to help raise funds. The PCC are applying for a grant, the proposal to the National Lottery fund was not successful.

Tim Pick will be new bank signatory. He will be set up on the banking mandate.

13. Village issues:

Dog fouling, fly tipping & boundary Changes

MS noted an increase in fly tipping in recent months especially since changes have been made to recycling centre.

MS mentions that there is a consultation going on about parish boundaries.
